*Chairman Rape made a motion to transfer \$30,000 from the NextTier and \$100,290 from PLIGT General Fund to total \$130,290 for project funding into the Capital Reserve Fund. Chairperson McElhinny seconded the motion, motion passed unanimously.*

**SOLICITOR:**

- The contract from Swede for the new township building was presented to the Board of Supervisors

*Vice Chairperson McElhinny made a motion to approve and sign the Swede contract for the new Forward Township Municipal Building. Supervisor Lees seconded the motion, motion passed unanimously.*

- Engineer Jeff Argyros provided an update on the MS4 waiver application.

**ROADMASTER**

---

*Chairman Rape made a motion to hire Paul Merten III at the rate of \$16.00 as a full time road crew employee with benefits after a 90 day probation. Vice Chairperson McElhinny seconded the motion, motion passed unanimously.*

*Supervisor Lees made a motion to advertise for the following materials:*

*- 6,000 tons of 2A Modified                      - 300 tons of #57 Limestone                      - 100 tons of R4 Rip Rap  
- 400 tons of #8 Limestone                      - 100 tons of #3 Limestone*

*Vice Chairperson McElhinny seconded the motion, motion passed unanimously.*

*Supervisor Lees made a motion to approve the follow colors for the new Forward Township Municipal Building:*

*Roof – Light Stone (63)                      Siding – Hawaiian Blue (70)                      Wainscoting – Khaki (88)*

*Chairman Rape seconded the motion, motion passed unanimously.*

*Supervisor Lees made a motion to approve the new Forward Township Municipal Building exterior window color to be white and the interior color to match stain of interior trim. Chairman Rape seconded the motion, motion passed unanimously.*

- Roadmaster Behm informed the supervisors that the site plan and building permit have been approved for the new township building.
- Roadmaster Behm stated on April 17, 2017 the base will be put down on George Road
- Roadmaster Behm presented the Board of Supervisors with the TIS Scoping Meeting Application from Gibson-Thomas Engineering in regards to the Hidden Acres residential development. The supervisors stated that the developer, Frank Shipley, will be responsible for doing a traffic count and provide any necessary signal retiming at the intersection of Evans City Road & Reibold Road upon full build-out of the site.

- Forward Township was contacted by Gigliotti Properties requesting reducing their bond. *Supervisor Lees made a motion to reject the request from Gigliotti Properties in reducing their bond. Vice Chairman McElhinny seconded the motion, motion passed unanimously.*
- Allegheny Aquatic Alliance requested to change dates of park usage to June 17 & 18, 2017. The supervisors approved the date change but need proof of insurance before they will be able to use the park.
- Recycling Day is May 13, 2017  
*Supervisor Lees made a motion to allow Roadmaster Behm to operate high lift for Recycling Day. Vice Chairman McElhinny seconded the motion, motion passed unanimously.*
- Roadmaster Behm asked the supervisors if they would like to rent a car to drive to the Spring Convention.  
*Chairman Rape made a motion to allow Roadmaster Behm to rent a car for the drive to the Spring Convention in Hershey PA. Vice Chairperson McElhinny seconded the motion, motion passed unanimously.*
- Roadmaster Behm asked the supervisors for permission to throw away items that have no value (computer tower, 2 printers, Echo weed eater, and Stihl 026 chainsaw).
